In January, Joan Gordon submitted a well-deserved nomination of Kathy Green to the **2024 Governor's Awards for Outstanding Volunteer Services**. The nomination was on the basis of Kathy's countless hours of service to South Coastal Village Volunteers (of which Joan is a part), FOSCL and the BBCT, and Justin's Beach House. Representatives from the three organizations prepared written tributes for the nomination. In particular, Phyllis Rigotti, Judy Johnstone and Rosemary Hardiman wrote a lovely letter that Joan incorporated into the nomination form.



The Governor's Outstanding Volunteer Service Award, administered by the State Office of Volunteerism, honors exemplary service and the true spirit of volunteerism by recognizing individuals and organizations making a difference across Delaware communities through volunteering. Recipients of the Governor's Awards must exemplify the following characteristics:

- Demonstrate sustained volunteer commitment to meeting Delaware's most pressing human and environmental needs
- Engage in meaningful volunteer service that makes a measurable difference in the community
- Represent extraordinary acts of generosity and kindness: and through volunteerism, have an impact on Delaware communities.

Governor John Carney will present the 2024 Governor's Volunteer Service Awards to 17 individuals, six groups, seven emerging youth leaders, and one corporation during an April 4 ceremony to recognize their exceptional volunteer service.

On March 7, Kathy and Joan were notified by phone that Kathy had been selected as one of the winners of the award. Joan shared the good news with us then followed up a day or so later with information on the April 4 event at which the awards are to be presented. I shared that with the Executive Committee and the Tour Committee members involved in the process, but was remiss in not sharing the news with all of you right away. My apologies. I hope it may still be possible for some FOSCL/Tour

representatives to attend the reception/dinner event in Dover to see Joan receive the award on Kathy's behalf. The reception will be Thursday, April 4 from 5-8 PM at the Modern Maturity Center in Dover. Tickets are \$50, including a cocktail hour and dinner. A delegation of eight from South Coastal Village Volunteers will attend.
