Friends of the South Coastal Library Board of Directors Meeting Tuesday, April 26, 2024, 7:00PM President's Report

Let's give Kathy a red carpet welcome and Hip Hip Huzzah at our meeting this week. We are all so proud of Kathy and grateful for her deep knowledge of everything library in Delaware, and her stewardship of the Beach and Bay Cottage Tour.

Board Nominations and Treasurer: Our Bylaws state that our Board must be no fewer than 11 members and no more than 19. We are currently 17, with Lisa Saxton, Steve Embrey and Connie Dierman completing their first of two possible terms, and Lawrence Mayer rotating off. Many thanks to all Board members who have spread the word, particularly Lisa S and Edie who have each brought us a well-qualified candidate for Treasurer. Fingers-crossed that we receive an application submission from BOTH of them!

Cottage Tour: Tickets went on sale April 1st. Woo hoo! The season is officially underway.

Friends of Delaware Libraries (FODL): The FODL annual meeting took place April 8, 2024 at the Georgetown Public Library. Presentation topics were on recruiting new board candidates and on developing and completing grant applications. There were some useful tips from this as I developed a FoSCL/School Partnerships presentation folder and worked with Lisa H and Kathy G on The Freeman FACES site visit. Great, big waves of kudos to Connie who QB-ed an application that got us through the first round. Likewise to Lisa S who made us look really, really good for our site visitor in so



many ways, and Kathy G who always represents us with expertise and passion. This is so big for FOSCL!

ad hoc Development Committee: This group is on the move. In addition to the multiple new giving opportunities established for FoSCL, and the two grant applications developed and submitted, the group is closing on an agreement for a Cooking For A Cause event this Fall. I joined them for a meeting with Megan Allen, Marketing Manager & Jeffrey Osias, Chef & Owner from Difebo's to explore the idea. More on that from the ad hoc committee!

Advocacy: I sent a message on behalf of FOSCL in favor of Increasing Library Standards Funding for Delaware Libraries in FY2025.

The Delaware Council on Libraries made a case before the Joint Finance Committee to increase the Library Standards budget by \$2,255,000 for the fiscal year 2025. This boost will raise the Library Standards budget line to a much-needed \$8.5 million. Despite substantial capital improvements in our public library infrastructure over the past decade, state funding for library operations has not kept pace. This <u>discrepancy threatens to undermine</u> the value of our investments and limits the potential services that our libraries can offer. The proposed increase is <u>more than a number</u>; it's about sustaining a thriving library system across all three counties. HB299, the Delaware Libraries for All Act, is about literacy, learning, and personal growth for all our neighbors.

FOSCL Identity Items: With the funding approved in the FY 2024 budget (\$1,680.00), we moved forward on a few of the FOSCL "identity" items: I updated the rack card and we have 2000 in the FoSCL office; Kathy G designed and ordered one logo tablecloth (we need a total of six for the 2024 in-person Tour homes and will also use them for the Book Sale, places we exhibit, etc.) and we now have plain white pocket folders with logo stickers for presentation meeting situations such as prospective Tour homeowner visits, grant applications and site visit, etc. Our opportunities have expanded, and we will need a budget supplement in order to replace the banners that hang in Bethany Beach during July, for the additional tablecloths to help Tour goers better understand the relationship between FoSCL and the Tour, for a retractible vertical banner to draw attention to our exhibit, and for the purchase of some small give-away FoSCL item(s) when we exhibit at places such as the Boardwalk Arts Festival, community events at nearby towns, etc.
